Trinity Valley Community College is associated with an independent foundation, Trinity Valley Community College Foundation. Ron Baugh and Jean McSpadden, located at TVCC, 100 Cardinal Drive, Athens, Texas 75751, manage the investments of the Foundation. The foundation's market value of investments at 8/31/07 totaled \$1,821,600 as follows: \$1,130,084 in certificates of deposit, \$4,711 corporate bonds (AAA/Aaa), \$407,536 in mutual funds and \$279,269 in money market funds.
