Trinity Valley Community College does not use soft dollar arrangements.

Trinity Valley Community College is associated with an independent foundation, Trinity Valley Community College Foundation. Glendon Forgey and Jean McSpadden, located at TVCC, 100 Cardinal Drive, Athens, Texas 75751, manage the investments of the Foundation.
