**Please read the following policies carefully. (These policies are available in full text on the TVCC financial aid website.)**

- I understand any monies due over and above my financial aid award are my responsibility.
- I understand I may receive financial aid **ONLY** for those courses **LISTED ON MY DEGREE PLAN** for which I have not already received credit at any institution. I will not be paid financial aid funds for courses I am repeating.
- I understand if I have attempted over 30 hours of developmental classes, any developmental hours that I enroll in will not count toward my funded enrollment status for financial aid. I understand I may receive financial aid for up to 150% of my degree plan. The total hours will include all hours **ATTEMPTED** at any school, even if I **did not** receive financial aid.
- I understand student loan funds will not pay any charges until after the funds have been received from my lender; therefore, I may need a temporary loan to cover tuition and fees. If I am a 1<sup>st</sup>-time borrower, a temporary loan **MAY BE ABLE** to be approved only after I provide proof that I have signed my Master Promissory Note.
- I understand if I withdraw from a semester or do not complete at least one course successfully during a semester in which I have received financial aid that I may have to **REPAY** some of the aid I have received for that semester. I further understand if I owe a repayment of financial aid funds, I may be blocked from re-enrolling, receiving an academic transcript, or receiving additional financial aid until the balance owed is paid and cleared from my record.
- I understand I must maintain a 2.0 grade point average (GPA), both current and cumulative, and **pass a minimum of 6 hours if attending half-time, 6 hours if attending three-quarter time, or 9 hours if attending full-time.** If this requirement is not met for two semesters, I understand that I will be placed on financial aid suspension.
- I understand if my financial aid has paid a balance on my account for an upcoming semester and I am placed on suspension, the awards will be taken out of my account and I must pay my fees in order to keep from being dropped for non-payment.
- I understand TVCC will return any and all credit balances to me within 14 days after the credit balance is determined. In the event that it becomes impossible to do so, due to uncontrollable events, I authorize TVCC to hold my credit balance owed to me until the credit balance disbursement can be generated. I authorize TVCC to use any financial aid awards, including student loan funds, to pay any monies owed to TVCC before releasing my credit balance to me.
