Colleen Doolin Skinner Distinguished Alum

Colleen Skinner graduated from TVCC in 1973 and now runs her own family law practice in Dallas.

TVCC eyes new master building plan

TVCC has completed \$12 million in new construction and renovations over the past decade and is now making plans for more growth in Athens, Terrell and Palestine.

TVCC President Ron Baugh said the plans are still in a preliminary stage, but said the plan will address needs identified by each campus dean.

In Palestine, the greatest need, he said, is for a new maintenance building, and in Terrell, a new library. He said the Health Science Center in Kaufman is in need of expansion as well, but the property there belongs to Memorial Hospital, so no plans have yet been developed for expansion there.

Most of the new construction will be on the Athens campus, where the plan calls for a new technical building, new gymnasium and field house, expansion of the Fine Arts Building, and renovations of the existing Men's Gym and Technical Building. Alton Tompkins Gym, the last of the old army barracks buildings moved to the campus in the 1940s would be demolished.


Baugh said there will be other maintenance needs at the campuses that will need to be met, such as the heating and air conditioning system at the Palestine campus, but said the plan addresses current construction needs of the campuses.

In Palestine, Baugh said the need for the new maintenance building could be met by locating a pre-engineered building on the campus.

The plan proposes a 32,000 square-foot library for the Terrell campus that would include distance education classrooms, offices and the learning resource center. How the space of the current library would be used has not been determined.

Construction in Athens has been divided into four phases. What's completed in each phase is still in discussion, but the final building plans were expected to be ready for board approval by its July meeting.

Under the current plan, a new Technical Building will replace Tompkins Gym, and a new gym and field house will be constructed near the football practice field. The Fine Arts Building would receive one, or possibly two, new wings, and Men's Gym would be renovated for student activities and to meet the needs of the Cardettes and

Cheerleaders.

Over the past 10 years, TVCC has completed construction of a new maintenance building, academic building, learning resource center and a residence hall, as well as renovated other buildings on campus, including the administration building.

TVCC entered its first master building plan in 1990 with no funds set aside for construction. The college used reserve funds to quickly build a \$4.1 million building fund and began construction in 1992. TVCC completed all new construction without borrowing a penny and while maintaining a low property tax rate and low tuition for its students.
