- 2. Emergency Storm Repairs to the Terrell Campus 1200 East Interstate 20, Terrell, Texas, 75160.
- 3. Determination by Board that the delay that would be caused by having to comply with the contract methods set forth in Tex. Educ. Code § 44.031 would prevent or substantially impair classes or essential educational activities of the college.
- 4. Delegation to the College President power to contract for the necessary emergency repairs or replacement to the Terrell Health Science Center and Terrell Campus facilities, as such repairs are necessary for the health and safety of Trinity Valley Community College students and staff.

An emergency or urgent public necessity exists that requires immediate action of the Board or an imminent threat to public health and safety or a reasonably unforeseeable situation exists, as follows:

Items 1-4 above: The May 28, 2024, severe thunderstorm/wind damage to the Terrell Health Science Center, and the Terrell Site Campus (I-20), and the resulting severe facility damage and disruption to classes and the possible emotional trauma of students and staff in response to this emergency.

If, during the course of the meeting, discussion of any item on the agenda should be held in a closed meeting, the board will conduct a closed meeting in accordance with the Texas Open Meetings Act, Texas Government Code chapter 551, subchapters D and E or Texas Government Code section 418.183(f). Before any closed meeting is convened, the presiding officer will publicly identify the section or sections of the Act authorizing the closed meeting. All final votes, actions, or decisions will be taken in open meeting. [See TVCC Board Policy BDA(LEGAL)]
