**Payment:** Payment for the tuition, fees, books and/or bookstore supplies indicated above (collectively “Costs”) shall be those established by TVCC and are subject to change. After TVCC’s drop date, TVCC will invoice Sponsor at the contact address listed herein and Sponsor shall pay same in full within thirty (30) days.

**Financial Aid:** This Sponsorship is in addition to any other financial aid (if any) received by the student listed herein. If there is an excess credit balance, it shall be refunded to:       Student       Sponsor

**Collection:** By signing this Agreement, the Sponsor understands that the College is relying upon the Sponsor’s promise to pay the student’s tuition and fees in order allow the student to enroll in its courses. The Sponsor understands that its non-payment of the charges will grant the College the right to pursue a claim for detrimental reliance and breach of contract against it. To the extent allowed by law, the Sponsor further agrees to waive any legal defenses to such claim and to pay any associated collection costs which the College incurs after sixty (60) days from the date of the invoice to the Sponsor.

**Termination:** This Agreement shall not be terminated after it is executed and is binding for the time period referenced above.

**Acknowledgement and Agreement:** Sponsor agrees and understands that this sponsorship Agreement is a contract between TVCC and Sponsor, in which Sponsor agrees to be liable for the sponsored student’s financial obligations to TVCC, according to the terms specified in the Agreement. In signing below, Sponsor acknowledges that it understands the components of the above listed Costs and agrees to timely pay them in full, without any selective omissions.

In signing below, the signatory affirms that they have read and agree to the terms and conditions stated above as well as those attached as **Exhibit A** to this Agreement, which are fully incorporated herein.

The individual signing below hereby represents and warrants that he/she is duly authorized to execute and deliver this Agreement on behalf of Sponsor and that this Agreement is binding upon Sponsor in all respects. The parties indicate their acceptance of all terms by their signatures below:

## EXHIBIT A

### Additional Terms and Conditions

#### Statement of Contract

This is a binding contract between TVCC and the Sponsor in which the Sponsor agrees to take responsibility for the sponsored student's financial obligations to TVCC, according to the terms specified in the Agreement.

#### Statement of Liability

After this Agreement is signed by the parties, all financial liability of the sponsored student is transferred to the Sponsor for the term specified in the Agreement. Any financial or conditional arrangements made between the student and the Sponsor are solely between the Sponsor and the student, with no bearing on the liability the Sponsor has to TVCC. Therefore, any obligations not fulfilled by the student to the Sponsor including, but not limited to, non-completion or failure of classes, will have no effect on the Sponsor's contractual liability to TVCC.

#### Statement of Agreement to Pay All Fees

All fees associated with the student's enrollment at TVCC are mandatory, and the payment of these fees are a nonnegotiable condition of the student's enrollment. Therefore, if a Sponsor agrees to pay fees, the Sponsor must pay all of the fees assigned to the student or none at all. Selective payment of fees is not allowed. Fees include: General Fees, Online Fee, Lab Fees, and Out of District Fees. See the TVCC Catalog for more information on our website [tvcc.edu](http://tvcc.edu).

#### Governing Law/Venue

This Agreement is governed by Texas law and venue for any lawsuit related to this Agreement shall be Henderson County, Texas.

#### Student

This Agreement does not alleviate or reduce student's liability or responsibility to pay TVCC in the event of breach by Sponsor or in the event Sponsor does not pay all Costs.

#### Authorization and Payment Terms

Third Party Sponsorship Agreement forms must be submitted to the business office by the semester payment deadline. A student's failure to do so will result in the student being dropped from their classes and their registration canceled unless the student makes other payment arrangements by the payment deadline.

Invoices will be mailed after the last day for refundable withdrawals and are due 30 days after the invoice date. Failure to pay any past due balances in full may result in the following:

- Loss of ability to Sponsor students until the past due balance is paid
- Loss of ability to be invoiced and requirement of prepayment in the future
- Reporting of nonpayment to credit reporting agencies resulting in weakened credit history
- Subjection to TVCC collections process
