Learning Outcomes: Upon completion of this course, the student should demonstrate a mastery of the following learning outcomes:

- 5) Demonstrate an understanding of foundation plan material requirements and practical proficiency in drawing and detailing a typical wall section
- 6) Demonstrate an understanding of typical wall section material requirements and practical proficiency in drawing and detailing a typical wall section
- 7) Demonstrate an understanding of door and window schedules
- 8) Demonstrate practical proficiency in drawing and detailing elevation views
- 9) Demonstrate an understanding of electrical requirements and practical proficiency in drawing and detailing an electrical plan
- 10) Demonstrate an understanding of heating and air-conditioning requirements and practical proficiency in drawing and detailing a mechanical plan.

Course Requirements: Complete a set of residential architectural plans designing a home to a given specification. Complete unit assessment questions.

The letter grade will be determined by average. A=100-90, B=89-80, C=79-70, D=69-60, F=below 60

Expected Time Requirement for this Course: Approximately five to six hours per week of time spent reading, reviewing, and completing assignments is recommended to complete this course.

Non-Attendance and Financial Aid: If you are receiving financial aid, federal regulations require you to have begun attending the courses for which you are enrolled on or before the census date (e.g., 12th day of each fall and spring semester and 6th day of class each abbreviated semester). Classroom Policies: Responsibility for class attendance rests with the student. Regular attendance is expected. The student is expected to participate in class discussions and share any personal experiences that may lend to the overall value of this course. When a student has a legitimate reason for being absent, the instructor has the option of permitting the student to make up work missed and may require explanation for the absence. TVCC is a tobacco free campus. Smoking, dipping, chewing, or any other use of tobacco products is prohibited on campus. There will be no food or drinks allowed in the computer lab. Please turn off or switch to vibrate any electronic communication devices during class times. Do not answer above devices in class, step into the hallway to do so. Do not text during class. Second violation of this policy earns you a falling grade for the day's assignment. Third violation of this policy earns you a falling grade for the course.

Cheating/Plagiarism: Scholastic dishonesty shall include, but not be limited to, cheating on a test, plagiarism, and collusion. "Cheating on a test" shall include

- Copying from another student's test paper
- Using test materials not authorized by the person administering the test
- Collaborating with or seeking aid from another student during a test without permission from the test administrator
- Knowingly using, buying, selling, stealing, or soliciting, in whole or in part, the contents of an unadministered test
- The unauthorized transporting or removal, in whole or in part, of the contents of the un-administered test

- Substituting for another student, or permitting another student to substitute for oneself, to take a test, and
- Bringing another person to obtain an un-administered test or information about an un-administered test.

"Plagiarism" shall be defined as the appropriating, buying, receiving as a gift, or obtaining by any means another's work and the unacknowledged submission or incorporation of it in one's own written work. "Collusion" shall be defined as the unauthorized collaboration with another person in preparing written work for fulfillment of course requirements.

The punishment for cheating or collusion in this class is a failing grade for the assignment for the first offense. The second offense will result in a failing grade for the course.

Drop Policy: The TVCC catalog states that the instructor <u>may</u> drop a student for excessive absences. However, it is the student's responsibility to withdraw from this class. To initiate a student withdrawal, you must call or go to the Counselor's office and complete the official paperwork. If you do not officially drop, you will be given a grade in the course commensurate with the work you have completed, usually an F.

A student may withdraw (drop) from a course and receive a grade of "W" at any time during a given semester subject to the last day to receive a "W" deadline specified in the TVCC schedule or catalog.
