

**Trinity Valley Community College CARES Act
Higher Education Emergency Relief Fund
March 31, 2022 Report**

- 1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.**

TVCC signed the Emergency Financial Aid Grants to Students Agreement and Assurance to provide Emergency Aid Grants to Students on April 14, 2020 and received the GAN agreement and funds on April 24, 2020. No less than 50% of the funds will be used for Emergency Financial Aid Grants to Students.

- 2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.**

TVCC received \$7,101,916 for Emergency Financial Aid Grants to Students as of May 14, 2021. As of March 31, 2022, TVCC has drawn from G5, the Department of Education's grants management system \$7,101,916 in funds

- 3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).**

As of March 31, 2022, \$7,101,916 has been distributed to students under Section 18004(a)(1) of the CARES Act.

- 4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.**

There is an estimated total of 9,600 students that will be eligible to participate.

- 5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.**

The total number of students who have received an Emergency Financial Aid Grant as of March 31, 2022, is 9,580.

- 6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.**

Student enrolled in the Fall 2020, Spring 2021 and/or Fall 2021 semesters were awarded \$313 for one semester enrollment, \$627 for two semester enrollment and \$940 for three semester enrollment. Students that do not meet eligibility for these grant funds are: TDCJ students, undocumented students, and students who withdrew.

- 7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.**

Students were made aware of the grant via TVCC email accounts, Canvas, social media, TVCC website, campus marquee, local newspapers and the TVCC alert system encouraging students to check their TVCC email for related information.
